CREDIT POLICY

Although it is not **PAC International, LLC's** intention to cause you undue hardship, **PAC International, LLC** must collect it's receivables as efficiently as possible in order to continue quality service to our clients.

ACCOUNT STATUS

The customer understands and agrees that the terms of purchase are 1% discount (after deducting freight) for payment on or before 10 days from date of invoice, Net 30 days from date of invoice. Any additional discounts or special conditions will be so stated on your invoice. All goods and freight are FOB Canby, OR. Any balance outstanding beyond the normal cut-off date is "Past-due". All past-due accounts will be placed on a cash sale basis, until the account is placed on current status.

SERVICE CHARGES

Past-due accounts are subject to a minimum \$2.00 late charge, plus a service charge of 1.5% on the unpaid balance (1.5% is an annual percentage rate of 18%). This is a fee to cover the costs of the additional handling required. In order to keep **PAC International, LLC's** charges as low as possible, we must assess these costs to those clients responsible for causing their occurrence.

CREDIT TERMS

Customer agrees to pay all invoices when due, regardless of whether or not Customer has been paid for its work. **PAC International, LLC** may apply payments however it chooses, unless the Customer provides written instructions with their payment. All invoices will be deemed accurate and customer waives any right to later challenge **PAC International, LLC's** performance of the contract, unless customer notifies, <u>in writing</u>, **PAC International, LLC.** within 20 working days of invoicing or receipt of goods.

RETURN POLICY

An invoice dated within 90 days with a return authorization is required for all returns. All returns must be in 100% saleable condition and contain all original product packaging. All items are subject to a 20% restocking fee and the customer pays for all return shipping costs. Note that shipping and delivery charges are not refundable.

SECURITY

As security for **PAC International, LLC's** extensions of credit, I/we hereby grant **PAC International, LLC** a security interest in my/our personal property, wherever located and now owned or later acquired, including goods, equipment, inventory, accounts receivables, general intangibles, instruments, chattel paper, contract rights, or the like.

I/we agree that this application shall constitute a security agreement to **PAC International, LLC**, and it may be filed by **PAC International, LLC** in such a manner that it will qualify as a financing statement under the applicable provisions of the statutes of any state which has adopted the Uniform Commercial Code. **PAC International, LLC** may add such schedules to this application, describing specific items of security covered hereunder as is reasonably necessary under such statutes.
